- 8. Applications to vote by proxy must reach the Electoral Registration Officer by 5pm on Wednesday, 24<sup>th</sup> April 2019.
- 9. Applications to vote by emergency proxy at this election on the grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer by 5pm on Thursday, 2<sup>nd</sup> May 2019. The physical incapacity must have occurred after 5pm on Wednesday, 24<sup>th</sup> April 2019. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 24<sup>th</sup> April 2019.
